Journey rates do not include airfare. **MasterCard, Visa, checks and money orders** are accepted. Please make checks payable to **Carole & Claire**. A **non-refundable deposit of \$500** of your journey rate will secure your reservation along with your registration form. Another installment of **\$1500** will be due January 1st. Balance of **\$1500** will be due no later than August 1. Fee covers full participation in the journey's 7 days. It also includes shipping your work FedEx back to the U.S. Payment in full at the time of reservation avoids service fees. Rooms are double occupancy and are available on a first come, first served basis. Stowaway roommates are not permitted. We will send/email your Journey Confirmation Packet with additional information needed for trip preparation prior to your departure.

All Tuscan Journey guests must read and agree to the terms of Tuscan Participant Agreement, Release, and Assumption of Risk form prior to registering for a journey or booking travel arrangements. The Release form is included as part of this Registration form via download from our website www.caroleandclaire.com or we will gladly email or mail a copy to you.

Cancellation Policy: "Cancellation" is defined as not attending your scheduled Tuscan journey, including postponing or rescheduling. "You" refers to the guest booking a journey. "We" refers to C&C Tuscan Painting Journeys for Women, Carole Foret & Claire Kayser. **It is your responsibility to read and understand our cancellation policy before making a reservation.** Naturally, no one books with the intention of canceling or postponing her journey, but unexpected things do happen, so please consider purchasing travel cancellation insurance. Depending on the policy and conditions, travel cancellation insurance will pay for some or all cancellation fees. So please consider this when booking your journey.

If you cancel or change your journey, C&C Tuscan Painting Journeys for Women does not offer cash/check or credit card refunds for any reason. A portion of your payment may be used as **credit** for another journey within two years of your original journey date. We will gladly transfer your credit to another guest and/or Tuscan journey. Depending on when you cancel, cancellation fees may apply. Fees are determined by the following schedule: If you cancel more than 90 days before your journey start date, 100% of your payment may be applied to another Tuscan journey. If you cancel 60-80 days before your journey date, 70% of our payment may be applied to another Tuscan journey. You will forfeit 30% of the price of your journey, if you cancel 15-59 days before your journey start date, 40% of your payment may be applied to another Tuscan journey. You will forfeit 60% of the price of your journey. If you cancel 14 days or less before your journey start date you will forfeit your entire payment. Exception to our policy cannot be made for any reason, including weather, injury, or personal emergencies. We do not offer credit for arriving late or leaving early. You must submit your signed Reservation Form and Participant Agreement, Release, and Assumption of All Risks Form within one week of booking or 90 days prior to your journey start date, whichever comes later. Guests who fail to do so, may be subject to an automatic cancellation and the above policy will apply.

If we cancel or change your journey, you may transfer your full journey payment to another journey, or you may request a refund of your payments to us, constituting a full settlement. C&C Tuscan Painting Journeys is not responsible for your expenses incurred in preparation for any canceled journey, such as airline tickets, loss of work, an/or other costs associated with preparing for your trip. **Please sign below confirming that you have read and understand the above Cancellation Policy AND have also read and agree to the Participant Agreement, Release, and Assumption of Risk form and agree to the terms therein. Participant Agreement, Release, And Assumption of Risk

In consideration of the services offered by C&C Tuscan Painting Journeys for Women and our associates including the hotel accommodations, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "C&C"), I hereby agree to release, indemnify, and discharge C&C, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that activity entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, among other things: Falling which could result in cuts, bruises, abrasions, or concussions; sprains, strains, broken bones, paralysis, even death. Furthermore, C&C instructors and staff have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities.
2. I expressly agree and promise to accept and assume all of the risks existing in the activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks, known or unknown.
3. I understand, that should I become disruptive to the program, rude or abusive to C&C guests or staff, create discomfort for other guests, or disregard safety standards, I may be asked to leave without compensation. C&C reserves the right to refuse service to anyone.
4. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless C&C from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity or my use of C&C equipment or facilities including any such claims which allege negligent acts or omissions of C&C.
5. Should C&C or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, agree to indemnify and hold them harmless for all such fees and costs.
6. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
7. In the event that I file a lawsuit against C&C, I agree to do so solely in the state of Alabama, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of laws rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
8. I understand that fine art painting requires the use of materials that may affect me adversely and although C&C will do their best to mitigate those effects, negative reactions to the painting process does not constitute a refund. I understand that weather, terrain, and other natural conditions including exposure to insects and micro-organisms such as bacteria and viruses are an inherent risk on a C&C Journey and are therefore not grounds for a refund.
9. I understand that at times, photographers may take photos or videos of guests for use in promotional materials such as websites, advertisements, catalogs, and magazine editorial. I do not expect any compensation for such use and also release to C&C that images may be used for C&C purposes. If I do not want my image captured I will inform a representative of C&C..

By signing this document, I acknowledge that if anyone is hurt or property is damaged in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against C&C Tuscan Painting Journeys for Women, Carole Foret & Claire Kayser on the basis of any claim from which I have released them herein.
